 - Eligible services must be ordered and acknowledged by nbn® between 01/07/2023 and 11:59pm AEDT on 31/12/2023.
 - Orders must be active and completed by 11:59pm AEDT on 31/03/2024.
- The promotion cannot be redeemed outside of the promotional period.
- · The promotion cannot be applied retrospectively.
- A promotional offer cannot be used in conjunction with any other offer.
