Aussie Broadband does not service Satellite NBN areas (or winners who only have ADSL capabilities at their residence). In the event a winner cannot be serviced by Aussie Broadband an alternative prize of equal value will be awarded in lieu of the Aussie Broadband NBN plans or the winner may transfer the Aussie Broadband portion of the prize to a family member or friend who can use the service. All Discounts available under this offer apply to internet or mobile plan fees only and do not apply to any additional services, charges or usage outside of your base monthly nbn or mobile plan fee, including any non-standard calls or messages that are charged on a pay-as-you-go basis; and any add-on data plans, international calling plans, international travel packs or other add-on plans that are available for purchase and use in conjunction with your base mobile plan.
