Eligible services	2. This promotional offer is applicable for eligible new and renewing on-net Aussie Fibre services. 3. Eligible services must pass a service qualification check, be within the existing on-net Aussie Fibre network footprint and must be confirmed by Aussie Broadband. 4. New service eligibility requirements: 4.1. The following Aussie Fibre plans are eligible: 500Mbps, 1000Mbps, 2000Mbps, 5000Mbps & 10,000Mbps. 4.2. New services must be ordered with a Partner Manager or using the Carbon portal. 4.3. New services must have a contract term for 36 months or greater. 5. Renewing service eligibility requirements: 5.1. Eligible renewing services are where an active and billed Aussie Fibre service is in place that is currently out of contract or within 90 days of an existing contract expiry date. 5.2. The following Aussie Fibre plans are eligible: 250Mbps, 500Mbps, 1000Mbps, 2000Mbps, 5000Mbps & 10,000Mbps. 5.3. Renewing services must be on an equivalent or higher plan speed than the current plan. 5.4. Renewing services must be ordered with a Partner Manager. 5.5. Renewing services must have a contract term for 12, 24, 36, 48 or 60 months. 6. Eligible services must be ordered and acknowledged by Aussie Broadband between 01/09/2026 8:00 am AEST and 31/12/2026 11:59 pm AEDT. 7. Eligible service orders must be completed and activated by 31/03/2027 11:59 pm AEDT.
